**1. CALL TO ORDER / WELCOME VISITORS –**

**3. ROLL CALL. QUORUM: Present-Alderman Jeff Burgess, Lisa Washington, James Gipson, George Cole Mayor Dick Ford**

**4. ADOPTION OF AGENDA- Alderman Burgess** made a motion to accept the agenda as written. **Alderman Washington** second, all in favor.

**5. APPROVE FINANCIAL STATEMENTS and COUNCIL MINUTES –Alderman Burgess** made a motion to accept the minutes and financial statements as written. **Alderman Washington** second, all in favor.

**6. MAYOR’S REPORT – Mayor Ford** stated the Christmas market was a success. There were over 100 Santa pictures taken, the vendors were happy with the turn out as well. A special thanks to Kyle Brummitt for helping with the tennis courts and the Christmas tree in the park.

**7. REPORTS AND COMMENTS FROM COUNCIL MEMBERS – Alderman Burgess** stated the tennis court lights are up and running. **Alderman Cole** and **Alderman Burgess** will meet with Johnny Gay to discuss work that needs to be done to the ditch at College St. and Hwy 29. There is a small pothole on Railroad St that needs to be filled with a bag of asphalt. Kevin needs to fill the pothole and clean the tennis court of leaves and debris. **Alderman Cole** stated that the trash in the ditches around town need to be cleaned out. Railroad St at the corner of Carroll St needs to be repaired. **Alderman Washington** stated the kitchen floors needed to be cleaned with vinegar they are very slippery. The double doors need to be fixed by the bridal room. The crosswalk sign needed to be replaced in front of the Mill. Trash in the park is still not being emptied as it should, a permanent schedule needs to be put in place. Pavilion needs to be painted once all the work is complete.
