- 1. CALL TO ORDER / WELCOME VISITORS** – Emily Gross, Rodney Vaughn, & Kyle Brummitt
- 2. INVOCATION and PLEDGE OF ALLEGIANCE**
- 3. ROLL CALL. QUORUM:** Present-Alderman Jeff Burgess, Lisa Washington, James Gipson, George Cole Mayor Dick Ford
- 4. ADOPTION OF AGENDA-** Alderman Cole made a motion to accept the agenda as written. Alderwoman Washington second, all in favor.
- 5. APPROVE FINANCIAL STATEMENTS and COUNCIL MINUTES** –Alderman Cole made a motion to accept the minutes and financial statements as written. Alderwoman Washington second, all in favor.
  - 6. MAYOR’S REPORT** – Mayor Ford stated the town received the franchise check from GA Power for \$20,482.32.

Alderman Burgess stated the county approved to help clean the ditches in the town limits. The county will provide a quote to mill & repair Railroad St. Flock is waiting for GDOT approval to install the cameras.   - C. **CONDEMNATION 248 RAILROAD ST.-** Mark Mitchell stated the town does have an ordinance for unfit structures. The town inspector will have to inspect the property first to see if repairs can be made before the council can proceed.

- C. **SPEED TABLES ON CHURCH ST-** Lewis Concrete came out to see where they could place speed tables on Church St. The quote for the speed tables is \$25,965.00. Council decided to table the speed tables until Church St. is ready to be paved.
